

The mission of the Sheriff's Office is to deliver exceptional public safety services to the public and to enhance the criminal justice system.


The ultimate goal is to prevent unlawful activity and bring individuals to justice who have committed unlawful acts.

Criminal Division

The Washington County Sheriff's Office, Criminal Division can be located at 309 Fourth Street, Marietta, Ohio. The Criminal Division is made up of Road Patrol, Detective Bureau, Task Forces, 911 Communication Center (Dispatch), Evidence and Supervisors for the respective area. Funding for the Criminal Division comes solely from a permissive ½ cent sales tax voted by the taxpayers in 1989.

The Dispatchers work 8-hour shifts, 24 hours a day. These men and women answer calls for not only the Washington County Sheriff's Office units, but 3 other police departments and 17 Fire/EMS departments.

Not all calls coming into the dispatch center are from 911. We also receive transfer calls from other agencies, and emergency calls as well as citizens coming on station.



The Washington County Jail is located at 101 Westview Avenue, Marietta, OH, on the west side of Marietta. The "new jail" began housing inmates on 9 July 2004. The staff is made up of a Jail Administrator, Assistant Jail Administrator, Administrative Corrections Assistant, Corrections Officers as well as Maintenance who cover the entire Sheriff's Office. The jail capacity is 124 inmates with 62 cells. Corrections Officers work 12 hours shifts. There are 2 shifts each day, 7 days per week.
